- AMENDMENTS TO THE TREATY ON EUROPEAN UNION AND TO THE TREATY ESTABLISHING THE EUROPEAN COMMUNITY
  - a) Page 14, Article 1, point 12, in the final sentence of the new text of Article 8 of the Treaty on European Union
    - For: 'Citizenship of the Union shall be additional to national citizenship and shall not replace it.'
    - Read: 'Citizenship of the Union shall be additional to and not replace national citizenship.'
  - b) Page 27, Article 1, point 30, in the new text of paragraph 1 of Article 13a
    - For: '1. The High Representative ..., shall contribute through his proposals towards the preparation of the common foreign and security policy ...'
    - Read: '1. The High Representative ..., shall contribute through his proposals to the development of the common foreign and security policy ...'
